# Cedar Lake Park Association: Thirty Years of Citizen Activism

In 1989 a group of citizen activists banded together to create a nature conservancy out of an old abandoned railroad yard just north of Cedar Lake. They claimed it, named it, and raised over \$500,000 to save the land for public use. They raised another half a million dollars to help fund an award-winning trail that would wind its way along the edge of the park. Since then day thirty years ago, the Cedar Lake Park Association (CLPA) has continued its mission to "Nurture Nature." Here are some of activities in the park the group carried out in 2019.

Over one thousand native-species flora were planted last spring in the Cedar Lake Prairie —continuing an effort that started in 1998. This year's rains fostered tremendous new growth. Since the earth there is mostly gravel and railroad fill, the survival rate for new plants is usually about 25%, but this year the rate has been 70%. While your basements may not have like all the rain, the prairie sure did.

Efforts continue around the lake to beat back the buckthorn. Battalions of volunteers have slashing and uprooting this pernicious pest. These efforts have produced a large area of open space, especially on the east side of the lake, and we've been quick to replace the buckthorn with native trees and shrubs to create a healthier biome.

On the educational front, years of effort have led to an officially designated School Forest in the area around East Cedar Lake (Hidden) Beach. Working with the Kenwood Elementary School, CLPA has created a place for students to come and learn about the natural environment—as well as learn how to dig in the dirt. They have planted and "seed bombed" areas to promote healthy growth. These young people will be the future stewards of Cedar Lake Park.

The Mound Project has entered its fifth year. Our plan to eradicate buckthorn and establish a more balance and verdant plant life around the Mound on the north side of the lake has been successful. Under the auspices of the Minneapolis Parks and Recreation Board (MPRB), CLPA has partner with Prairie Restoration Inc. in this effort. We provided funding and a vision of what we hoped the Mound can become: a more open and inviting space where people can come and reflect. We are pondering another long-term plan for the area.

CLPA has been working on documenting developments in the Kenilworth Corridor. A few years ago, we purchased a Go-Pro camera and took videos of the corridor. Our thought was to provide a history of what the Kenilworth Corridor was before the construction of the Southwest Light Rail Transit (SWLRT). Recently we

went out and shot footage of what has happened this year as clearing has begun in advance of construction. We will be out there once construction is over so we can get a "before, during, and after" view of the corridor. We also commissioned paintings of the corridor and we plan on making prints of them to put up in the corridor. We still have items on our plate.

CLPA has been in the forefront calling for the Met Council and Hennepin County to cede the thirty-eight acres of remnant land in the Kenilworth Corridor to the MPRB. This is land purchased for construction of the SWLRT, but not needed once the project is complete.

Meet Your Neighbor, Dan Rice, the natural wine enthusiast and co-owner of Bar Brava, Minneapolis' first natural wine bar located at 1914 N Washington Ave, Minneapolis, MN 55411 (www.barbravamn.com).

Where did you grow up and attend school? I grew up in Apple Valley and studied Finance and International Business at the U of M. The highlight of college was a fantastic and hugely formative study abroad experience in Barcelona, Spain.

What was your career path to wine? It was NOT the typical one. I came to wine because I loved learning the stories of the producers/vignerons and understanding how they literally put their passion into the bottle.

What is Bar Brava? Minneapolis first natural wine bar!

What is natural wine? Natural wine is wine made with organically farmed grapes and no additives, chemicals or preservatives. Like organic produce or food, many people find natural wine to taste better and to be healthier than conventional wine, which is often heavily processed with additives.

How can people best be introduced to and experience natural wine at Bar Brava? Stop by on Tuesday from 4-6 PM when we offer "flight school", which is typically 3-4 wines for \$20 with some wine knowledge to boot. We host with a round table format and provide snacks.

Where is Bar Brava located? Bar Brava is just a hop and skip from the Hill Lake area—literally one exit north (Broadway) on I-94 from Hennepin-Lyndale in Lowry Hill. We are located at the intersection of Washington Ave and Broadway, right next to the old BJ's bar at 1914 N Washington Ave, Minneapolis, MN 55411 (www.barbravamn.com).

County Board Adopts 2020 Budget

The Hennepin County Board approved a 2020 budget of \$2.5 billion. The budget includes an \$869 million net property tax levy, a 4.75% increase from 2019.

The budget focuses on reducing disparities that impact many residents in the areas of education, employment, health, housing, income, justice and transportation.

In addition to investments in public safety and transit, examples of some key budget drivers include:

- Child well-being continuing to transform the child welfare system to a child well-being model
- County workforce recruitment and retention of diverse county employees
- Shelter increasing in investment in shelter, to improve and expand service, and better support people securing permanent housing
- Elections preparing for the 2020 presidential election and addressing election security
- Census 2020 establishing the Complete Count Committee 2020 to maximize the number of county residents surveyed in the 2020 census
- Service centers meeting increased demand and providing better customer and employee experience
- Affordable housing establishing unprecedented funding for affordable housing and continuing investment strategies that spur the creation and preservation of affordable housing
  - Sustainable future completing a carbon emis-

sions inventory study that will empower the county to act on reducing our carbon footprint

### **TIPS FOR MID-WINTER SURVIVAL**

Women – Do NOT grow a beard! Even in our neighborhood of relentlessly good progressive activism, neighbors might have a hard time with the womanbeard (but if circus sideshow work is your dream job, go for it). Instead wrap your face in a soft scarf exposing only eyes and frozen lashes. You too will survive the winter in medieval style.

**Shovel snow**. I have long been a proponent of this healthful, rhythmic exercise, in



spite of convincing data that it induces heart attacks in geezerly males of the species. I have written ecstatic poems praising it. True, when our last child left the house for college, we immediately hired a service. But I do miss the rhythm of the blade, the thrust in the snow, the aching back, the exhausted nap.

Read a long novel. Some say summer is novel time, a beach read. But why read on the beach when you can swim! Winter is the Season of the Big Novel. Get up in the dark, read in the dark, go to bed in the dark, Moby Dick's ocean waves leaping before you, Captain Ahab at the helm leading you on toward disastrous whiteness.

Take a winter trip. But not South, murky with humidity and backward politics. Instead, trek North! For nearly 30 years my posse of friends has snowshoed along Superior's North Shore in February, followed by a sauna and a dip in Lake Superior. Madness? Look at me, 75, fit as a fiddle! OK, an out of tune, warped and cracked fiddle, capable only of tremulo. But still....

Dine sumptuously on leftovers and accumulated frozen foods. Let no scrap nor expiration date get in the way of winter nourishment. Pick that chicken carcass clean, then throw it in a boiling pot with water and soft carrots and soggy celery. Later boil up that large bag of

frozen pierogis the dynamic demonstrator at Costco charmed you into buying three years ago. So much to devour in the freezer before the spring thaw appears.

**Gin!** This suggestion came to me under the influence of Anthony's Lane's deeply researched, drop-dead hilarious article on gin in the Dec. 9 *New Yorker*. In our household gin and tonics are a year-round refreshment. Out for dinner, my wife orders a concoction called a "corpse reviver 2." I can speak to its effectiveness. She pinks right up.

There may be one or two more tips to survive the winter season I have missed, and I endorse everyone. Like Tiny Tim, the Urban Coyote wishes a happy winter to all! And like Santa after his Christmas deliveries, he looks forward to a long winter's nap.

# Civil Disobedience Protest

WASHINGTON DC, FRIDAY DECEMBER 6— Two Minneapolis women, Joann Martin and Kitty Westin, protested alongside actor and activist Jane Fonda on Friday, Washington, DC today.

The protest was held not be on the Capitol steps where recent previous demonstrations were held. Instead, the women, part of a Fire Drill Friday's group, joined with Shut Down DC and youth climate strike actions to focus on the connections between migration, human rights, and climate change.

The activists planned a civil disobedience action to shut down the building of a corporation doing business related to fossil fuels, based in downtown Washington near 14th and K Streets, yet report, no arrests for civil disobedience were made.

Martin, 85, a former Minnesota social worker and resident at The Kenwood retirement community in Minneapolis, joined Fonda today in DC at the request of her friend of over thirty years, Minneapolis resident Kitty Westin, an activist and friend to Fonda.

Fonda began her most recent civil disobedience protests at the US Capitol in Washington October 11, calling them "Fire Drill Fridays" in reference to Swedish climate activist Greta Thunberg, who said "our house is on fire". Fonda thereafter announced she would hold more Friday protests, wearing the color red, during her day off from filming a television show she has produced since 2015, "Grace and Frankie".

In October, according to news accounts, Fonda was arrested three times in consecutive weeks protesting climate change outside the Capitol. She was arrested October 11, with Grace and Frankie co-star Sam Waterston, on October 18, and with actor Ted Danson on October 25. On November 1, Fonda was arrested for the fourth consecutive Friday.

Westin, who is Martin's personal link to Fonda, is a psychologist and nationally recognized speaker on eating disorders, who established a foundation following the death of her daughter from anorexia in 2000. Westin

and Fonda know each other from their shared interest in mental health, as Fonda has spoken openly about developing bulimia in her adult years.

Martin and Westin said they decided to let themselves potentially be arrested. "I've never been arrested before but the inconvenience of being arrested will be nothing like the inconvenience my grandchildren will have if they don't have clean air and clean water," Westin said.

Like Fonda, Martin and Westin are grandmothers and great grandmothers, and quote Jane as "feeling far braver now" with "nothing to lose and this is it". Martin, who has been active in voter registration in previous years, said that she was motivated to protest today because she believes her generation should act for change alongside the younger generation, yet "if we do not show equal energy, it is not a good effort."

As a lifelong Minnesota resident, Martin said that she invited her Minnesota Senators, Amy Klobuchar and Tina Smith, and her Representative, Ilhan Omar, to join her group at the Capitol protest, and said that while she realized "getting arrested was a possibility, arriving home back in Minnesota was our goal".


### Hill and Lake Press and History



The Plan Modification is necessary in order to fund the purchase of security cameras for the public safety of the neighborhood. The cameras will be for the use of the Minneapolis Police Department. The meeting will be held beginning at 7 p.m. at Grace Trinity Community Church, 1430 W. 28th Street. The details of the proposed Plan Modification are below.


