### CITY SEEKS INPUT ON HENNEPIN AVE RE-DESIGN BY APRIL 16

The City of Minneapolis is re-designing Hennepin Avenue, from the Douglas Avenue intersection on the North end, all the way to Lake Street. Construction, originally scheduled for 2022, has been shifted to 2023 and 2024, and the City expects a final approved layout by August, 2021. The multi-phase project is now open for public comment on the city's website through April 16.

What's up for grabs? A lot. Two proposed options address adding bike lanes on both sides of Hennepin or in an alternative spot off Hennepin, designated lanes for new Bus Rapid Transit, a central median to slow traffic, allowances or eliminations of left-hand turns, and keeping or eliminating parking.

"Now is the time for residents and businesses in Lowry Hill, East Isles, and Lowry Hill East to speak up about what's most important," said Fran Davis, Lowry Hill Neighborhood Association Board Member. "These neighborhoods are directly impacted by the proposed changes; and public feedback is essential if the city is to have a balanced approach to transportation."

Both plans have been developed to meet city policy goals around transportation. And, the planners admit there are a lot of competing interests in the corridor – local businesses, neighborhood residents, urban transit needs, climate change. There's not enough space in the 88-foot right-a-way to accommodate all interests so it's important the public speak out about what's important.

Word of caution: if you're an urban planner, you might be able to decipher what's being proposed by examining the renderings of Option 1 and Option 2. If you're not, the 30-minute video "virtual open house 3" is a better way to grasp the scope of changes.

There's also a survey on the city's website about the project. However, without broader context about the

project, some residents have expressed concern about how answers will inform the final plan.

# The Mugo Pine Lives On by Kobi Conaway

The board of Friends of Thomas Lowry Park is excited and cautiously optimistic to announce an ongoing effort to cultivate seedlings from the iconic mugo pine located at the top of the Seven Pools. We're working in partnership with Kurt Herke of Phillips Garden who has agreed to take on this multi-year project out of a love of gardening, an interest in conifers and historic preservation.

In February, Kurt collected over 30 cones from the mugo pine and from those cones, he was able to extract



24 seeds. For now, those seeds live in a paper bag in his desk and are so small they would fit into a teaspoon.


If all goes well, the seeds will be planted in about a month. To get the seeds to germinate, Kurt will first soak them in water for 24 hours, drain them and then refrigerate them for about four weeks to create a 'cold stratification period'. Afterwards, the seeds will be sowed in 3" containers and we'll watch and hope for germination in 10 to 14 days. If germination of any of the 24 seeds is successful, we will need to be patient. It will take a few years until our baby mugo seedlings grow to a size that can be planted in the ground.





### Meet Your Neighbor

Craig Wilson interviews Todd Smith, a business owner along Hennepin Avenue, about his concerns related to the City's redesign of the Hennepin Avenue commercial corridor.

What is your concern about the City of Minneapolis' (City's) attempt to redesign Hennepin Avenue? I appreciate all the outreach efforts City staff and consultants have done in regard to planning around the redesigning of Hennepin Avenue. However, many residents and businesses remain concerned about the unintended consequences this redesign and reconstruction might have on small businesses located on the corridor, such as removing all street parking in favor of Bus Rapid Transit (BRT) and bike lanes. We have seen what happened to the redesign of Hennepin between Lake Street and 31st in Uptown—the loss of street parking has correlated with the loss of many businesses. Unfortunately, the bike lanes that were installed seem to have become loading and unloading zones for people running into stores, Lyft and Uber drivers, food delivery services, and mail deliveries. This now causes traffic to flow into oncoming traffic because road lanes are so narrow. I'm afraid the City will make the same mistakes, or we'll end up with an even worse scenario like massive red BRT lanes that are used infrequently and that become loading zones and speedways for cars passing on the right.

What works and what doesn't work with the project? I recognize and agree with many of the goals this project aims to address such as single traffic lanes with a shared turning lane, enhanced pedestrian experience, rapid bus lanes, etc. They are all worthy ideas. I'm an avid biker too and support bike lanes in appropriate places. The challenge is that the corridor is narrow and limited in what it can support—so we have to make tough decisions. I'm deeply concerned about the loss of street parking. At the virtual open house on March 9th, as with all previous presentations, parking particularities were not addressed. In fact, proposed design concepts eliminate all street parking along Hennepin Avenue.



Short term parking for local businesses is key to a successful and vibrant commercial corridor. With all the challenges to Hennepin Avenue businesses in 2020, such as the pandemic and social unrest, I fear that removing parking access to businesses will make it impossible to operate successful businesses on Hennepin Avenue, especially ones that lack surface parking lots.

How can parking work? Curbside demand varies tremendously block by block throughout Hennepin. We recognize that some parking is going to be eliminated but we believe these decisions need to be made very strategically. This needs to be done working with business owners. This could be a win-win scenario if thoughtful and comprehensive.

Do you feel the business community been adequately engaged? In Phase 1 of the Hennepin Avenue reconstruction from Lake St to 36th Ave S, it was a shared consensus amongst businesses that our input was not requested and subsequently discounted when at a late date the issue was pushed. I'm hopeful that won't be the perception with this phase and, in that spirit, business owners have officially asked to have a meeting between businesses and City staff and consultants. We really want to be at the table.

The design concepts put forward by the City suggest that Bus Rapid Transit (BRT) is a given and that parking is eliminated under both scenarios. It appears as if the real choice is between bike lanes with a large sidewalk or a really, really large sidewalk without bike lanes? That's correct. It appears as if the City has decided to replace parking with red BRT lanes. My concern is that while BRT lanes would be great, they will serve people moving though the corridor on a more regional scale and not necessarily the neighbors who live, work, shop or eat up and down the corridor. Given the limited space, I'm not sure we're able to host BRT lanes and maintain successful businesses.

What else is missing from the City's design concepts? Providing bump-outs to enhance the pedestrian experience, slow traffic, and create parking nodes seems reasonable and achievable but this isn't adequately addressed in either proposed concepts. The City seems more concerned with planning on a regional scale versus a neighborhood scale. The City and Hennepin County prioritized the region with SWLRT—now they seem to be saying the same for Hennepin Avenue with the BRT playing a "critical role" in the region's transportation network. The problem is that when businesses fail, many local residents with get in their cars to drive to the suburbs for services. How will this affect the regional transportation system as well as our local tax base and desirability to live in Minneapolis and pay

# Safety Tips — Keep Your Car Safe

There has been spike in carjackings and theft of catalytic converters, in our communities and nationwide. Here are a few tips to keep you and your car safe:

### Auto Theft Prevention – auto thefts always increase with the colder weather.

- Never leave your car running and unattended. A cold car is better than no car.
- ALWAYS take your keys and/or FOB with you. DO NOT leave your keys in your vehicle even if you are in an access-controlled parking facility or your own garage.

### Avoid Catalytic Converters Theft - they can be sawed off vehicles in a matter of minutes.

- Whenever possible, park your vehicle in a locked garage.
- Park your vehicle in well-lit areas. Add additional security lighting where needed.
- Set your car alarm to be more sensitive to detect tampering.


# Minneapolis Police Department IMPORTANT THEFT PREVENTION TIPS

Across the Twin Cities, there has been an alarming rise in Car Jackings, Auto Theft and Theft from Motor Vehicle, which includes license plates and catalytic converter theft.

The Minneapolis Police Department urges you to remain vigilant to any suspicious activity around your car. Suspicious activity may include people walking or driving up and down the street, alley or through garages/parking ramps and surface lots. Behavior may also include looking closely at vehicles or crawling underneath them.

Please Call 911 to immediately report locations and the descriptions of suspicious individuals and/or their vehicles.

- Catalytic Converters
- Converters can be sawed off vehicles in a matter of minutes. Vehicles with a higher ground clearance, such as AWD trucks, SUVs and mini vans are especially vulnerable.
  - Whenever possible, park your vehicle in a locked garage.
  - Park your vehicle in well-lit areas. Add additional security lighting where needed.
  - Install video cameras where you park.
  - Etch or engrave your License Plate number and/or VIN onto your Catalytic Converter.
- Spray paint your converter with brightly colored, heat resistant paint. This could help in making it easily identifiable at a scrap yard.
  - Set your car alarm to be more sensitive to detect tampering.
- Install an aftermarket anti-theft device. These are designed to make it more difficult for a thief to remove the converter. Several different versions are available through Auto Parts stores and online.
  - Talk to your mechanic or vehicle dealership for anti-theft devices specific to your vehicle make and model.
- If you are a business that operates a fleet of vehicles, consider securing them in a yard with high, locked fencing. Again, higher ground vehicles are more vulnerable to Catalytic Converter theft.
  - Auto Theft and License Plates
- Auto Theft Prevention has been a citywide focus. Never leave your car running and unattended. A cold car is better than no car. ALWAYS take your keys and/or FOB with you. DO NOT leave your keys in your vehicle even if you are in an accessed controlled parking facility or your own garage.
- Because 70% of vehicles are still being stolen with keys or FOBs in the vehicle, thieves are also stealing license plates to put on stolen cars. Check the front and back of your car frequently to make sure your plates have not been tampered with.
  - Thieves will also swap plates. They look for vehicles that match the same make and model of the vehicle

property taxes?


What's your hope for the future of this project? Moving forward, looking at the needs and uses along the corridor with insights from ALL stakeholders INCLUDING businesses, would be really helpful. It would be awful to go through this whole effort and end up with Fed Ex trucks and Uber Eats drivers blocking rapid bus lanes as an unintended consequence similar to the bike lanes on Hennepin Avenue between Lake St and 31st. The property taxes that commercial properties contribute is significant. When businesses fail, that tax basis will erode to the detriment of us all. This includes property taxes when neighborhoods become less desirable to live in. There are a lot of desires and competing uses that would like to be placed on Hennepin Ave, and unfortunately there just isn't enough space. It just takes one person to put on their flashers to run in to grab some Thai takeout to bring traffic to a standstill. I recognize I'm just acknowledging the harm here. It would be nice to have some measurable outcomes from the first phase of reconstruction on Hennepin Avenue between Lake St and 31st Street, but despite frequent requests, no one has been able to provide any quantifiable information on increased pedestrian or bicycle use or the success of businesses. Does it even exist? Who knows? Bottomline, we all want to make Minneapolis a great place to live, commute and SHOP! Let's be smart about how we balance these desires and really ask ourselves what's proven to be successful.

Burch's restaurant is dark. Anderson Cleaners closed up shop. Thankfully Kenwood Barbers, Sebastian Joe's and Patina remain robust in our little commercial corner of Covid world. Add to them, beginning late in the week of March 8, a stunning magic show, or better yet, a court Jester's show, free and open for your amazement inside the former Anderson Cleaner's shop at the corner of Hennepin and Franklin Avenues.

One of Billy's characters is a shrine to his grand-father, Dr. Robert Good, the world-famous Minnesotan remembered as the father of modern immunology who performed among many medical magic tricks the first successful bone marrow transplant. Another character is Billy's homage to a homeless person. Another praises Seb Joes. Another is... well, you will have to see.



ong-time Minneapolis developer Ray Harris moved into *The Kenwood Retirement Community* in January of 2020. After a fall, he spent a few months in the hospital and rehab, and returned to the Kenwood in March, at the beginning of the COVID-19 pandemic. He says he is "making the best of it" but he is doing more than that. He's started a blog, "Been There, Done That, Took Notes." It's a love letter to Minneapolis, filled with stories about streetcars, offleash dog parks, baseball, Orchestra Hall and more, projects that Ray himself developed, or historic reminiscences. He writes out the content for the blog in longhand, and gives it to The Kenwood's Executive Director, Jennifer Volkenant. She in turn scans it and sends it to Ray's granddaughter and she and her uncle work out the technical aspects.

In addition to reminiscing about Minneapolis history, and his work as a developer, Ray intends to write about how to make things better in Minneapolis in the future. Ray's hero is Don Quixote, and he often describes himself as a risk-taker and is known for taking on projects that others have said were ill-advised or impossible — the "Impossible Dream." He has always been attracted to projects that will make Minneapolis a better place such as Calhoun Square, Greenway Gables, the Loring Park Off-Leash Dog Park, and Chiron School to name just a few. Ray continues to work as an advisor and consultant in real estate development.

When asked why he chose to move into *The Kenwood*Retirement Community, Ray said he's lived his whole life in the neighborhood, and he likes the proximity to

friends, and business associates, and even when people could not visit him indoors because of the pandemic, Ray has had a steady stream of visitors outdoors. The Kenwood has all the services he needs. He enjoys making his own meals, but also orders dinners from the Kenwood's Lowry Hill Dining Room. When the weather is nice, he travels around the neighborhood in his "Lamborghini," his motorized wheelchair. He enjoys visiting his building projects in the neighborhood, such as Manor Homes of Lowry Hill (Douglas School Townhouses) at Franklin and Dupont, and the Mount Curve Place townhomes.

Ray is fond of saying that he hasn't worked a day in his life because he was his own boss and has enjoyed his work. And it's clear he hasn't retired. He especially likes putting people together; contractors, architects, politicians, whoever, and getting them to work together. Like his hobby of putting jigsaw puzzles together, Ray can see the big picture, but is also good at problemsolving, facilitating, and paying attention to details. All of these qualities have helped him adjust to his life at the Kenwood and cope with the difficulties all of us have had to face during the pandemic. He says above the waist he is moving at 200 miles per hour, and below the waist, he is moving at 2 miles per hour. 

### Call to order: Mary Pattock, Chair

Mary called the meeting to order at 6:02 p.m. The board approved the minutes for the February 10, 2021 meeting.

Report: Minneapolis City Council Ward 7, Lisa Goodman March Lunch with Lisa is cancelled; in April it will feature the AVIVO Village project in North Minneapolis, an interior, tiny home community alternative to encampments. (https://avivomn.org/).

Guest Report: MPD 5th Precinct Inspector Katie Blackwell, also part of team Operation Safety Net, logistics and military liaison:

Crime rose overall 20% in Minneapolis last year. CIDNA had no violent crimes, 12 property crimes, 1 burglary, 11 thefts of cars; there was an uptick in auto thefts throughout the 5th precinct (CIDNA had 2). Auto thefts occur more frequently when owners leave their car running while doing an errand or warming up the vehicle. Catalytic converter thefts are rising. Leaving valuables in open view in a car invites

The MPD has multiple teams dedicated to safety during the Derek Chauvin trial, including quick mobile response teams, firefighter assistance and prevention of property damage teams. There is no significant intelligence about outside agitators at this time. Estimated trial timing is 2 to 3 weeks for jury selection, 4 weeks for trial, with a verdict anticipated at end of April or beginning of May.

Extra law enforcement, including National Guard, is being called in, particularly during the time of verdict, to assure that peaceful protests can take place but not destructive behavior. Safety teams will be deployed throughout the city to deter unlawful behavior.

Traffic will be re-routed when necessary, minimizing major disruptions in traffic flow. Curfew decisions will be made by the mayor and the governor. No protesting on highways will be allowed because it is extremely dangerous.

Public should report suspicious activity by calling 911 or 612-348-2345. The City has a "Trial support and safety" website accessible from the city homepage at https://www.minneapolismn.gov

Appreciation was extended by all present to Inspector Blackwell for her service.

### Chair's Report, Mary Pattock

Plymouth Church has asked if CIDNA wants to co-sponsor with other neighborhoods a city council candidate forum. The Board decided it doesn't have the bandwidth to cosponsor but could promote such an event in its newsletter.

Rosanne Halloran, Search Committee Chair for CIDNA Coordinator, reported that the committee had 16 inquiries and is interviewing two finalists. The goal is to have a new coordinator hired by April 1.

CIDNA Annual Meeting will be on May 12, 2021. Suggestions for a featured speaker are welcome. Board retreat will be held in June.

### Report: Treasurer, Kevin Johnson

Robert Thompson, CIDNA's accountant, said CIDNA is healthy financially. Last month there was income of \$1600, expenses of \$964, and the current bank balance is \$27,000.

### Guest Report: Jack Whitehurst, Minneapolis Neighborhood & Community Relations Dept (NCR):

A steering committee including NCR Director David Rubedor, NCR policy specialist Steve Gallagher, city budget director, city coordinator, and council members Gordon, Cano, Reich and Cunningham meet frequently to discuss funding for neighborhood organizations (NOs). They are considering various funding options for the City Council to consider in April. One would increase total citywide funding by \$3 million starting in 2022, guaranteeing each neighborhood a minimum base of \$25,000. Otherwise, under the new Neighborhoods 2020 system, CIDNA funding would drop substantially from its current \$26,000. Under a new "Citywide Neighborhood Network Fund" CIDNA would receive basic funding of \$20,000, \$15,000 and \$10,000 in succeeding years, and have the option to apply for additional funds under the new Equitable Engagement Fund (for working on equity), Partnership Engagement Fund (working on equity with a community organization), and Collaboration and Shared Resources Fund (merging to some extent with another NO). We will have more information in a few weeks.

CIDNA earmarked \$20,000 of Community Participation Program (CPP) funding to the Cedar Lake South Beach for unfinished elements of the renovations at that site (e.g.,

canoe racks, public art), however, the money has not yet been formally contracted. The Environmental Preservation Committee will prepare a recommendation for the board. If the \$20,000 is not under contract by Dec. 31, NCR will move it to the new Equitable Engagement Fund. CIDNA also needs to contract the Propel funds, possibly again to Propel; the Executive Committee (board officers and committee chairs) will prepare a recommendation for the board.

At this point Mary Pattock had to leave and Tim Sheridan took over the meeting.

### Report: Interim Coordinator, Amanda Vallone

The regular March E-News had a 53% open rate; Monday's special trial-safety update so far has a 50% open rate. CIDNA has 98 followers on Facebook.

Southwest area Neighborhood Organization coordinators met on March 4th. 1) They discussed weekly NCR trialrelated meetings; each neighborhood should send a representative. 2.) Carlson Graduate program offers a volunteer consultant for a 10-week program to assist nonprofit organizations on strategic planning. 3.) Summer events are tentatively planned with the understanding they could be cancelled or strictly restricted. 4.) Hybrid models are being used for some annual meetings.

### Guest Report: Transportation Committee, David Davies, SWLRT Outreach Coordinator

Cement pour in tunnel floor has been tentatively pushed to the week of March 15. For firm date see https://metrocouncil.org/Transportation/Projects/Light-Rail-Projects/Southwest-LRT/Construction.aspx

Freight tracks are monitored carefully to keep site safe and secure. Excavation starting at north bridge in a few weeks, depending on ground thaw.

The Met Council will not know until summer the amount of their previously announced cost increases, which they said were due to 1) encountering soil conditions they were not prepared for, 2) a better understanding of the Bryn Mawr wall construction, and 3) undetermined delay in the project

A project worker was found unresponsive in construction area and eventually died due to a personal medical situation unrelated to workplace activity.

Report: Neighborhood Safety Committee, Stephen

Sidewalks are clear of ice and snow at Lake Street area north of Bde Maka Ska. Stephen suggested a bike lane in that area as bikers are using the sidewalk and creating a hazardous situation for pedestrians.

Officers from the Minneapolis Police Department and deputies with the Hennepin County Sheriff's Office Violent Offender Task Force teamed up recently with air support from the Minnesota State Patrol to target groups of individuals responsible for the on-going number of violent robberies and car jackings in parts of South Minneapolis. The three-day joint operation, which took place Jan. 26-28, resulted in 46 arrests, including 69 felony level charges. Law enforcement recovered 15 firearms and 12 stolen vehicles. 


